Local Law No. 2 of the year 2024

A local law amending Chapter 144 of the Code of the Village of Philmont to add
Parking restrictions to Canal Street.

Be it enacted by the Village Board of Trustees of the

Section 1. Be it enacted by the Village Board of Trustees of the Village of Philmont that Chapter 144 of the Code of the Village of Philmont is hereby amended to add Article XIV to read as follows:

Section 2. ENACTMENT.

ARTICLE XIV Canal Street Parking Restrictions

§ 144-50. Legislative Intent

Pursuant to the New York State Vehicle and Traffic Law § 1640 the Village of Philmont is enabled to regulate, prohibit, restrict or limit the parking of vehicles upon public highways maintained by the Village within Village limits. The Village Board of the Village of

Philmont has determined that vehicles are being parked on Canal Street for extended periods of time obstructing the village street, becoming a hazard, and parking restrictions are necessary to promote the safe and efficient movement of persons and vehicles on Canal Street within the Village of Philmont.

§ 144-51. Parking prohibition.

Vehicle parking on Canal Street shall be limited to a period of no longer than 24 hours.

§ 144-52. Enforcement. Any violation of this article shall be enforced in accordance with the provisions of this Chapter and the New York State Vehicle and Traffic Law.

§ 144-53. Title. This article may be referred to as the "Village of Philmont Canal Street Parking Prohibition."

Section 3. VALIDITY AND SEVERABILITY.

If any section or part of this local law is declared invalid or unconstitutional, it shall not be held to invalidate or impair the validity, force or effect of any other section of this local law.

Section 4. EFFECTIVE DATE.

This local law shall be effective in accordance with the applicable law after filing with the Secretary of State.


